EXPLANATORY STATEMENT PURSUANT TO SECTION 102 (1) OF THE COMPANIES ACT, 2013

Item No. 1:

As per Article 114.15.2 read with Article 115.3 of the Articles of Association of the Company, any transaction for, *inter alia*, transferring, Encumbering (as defined in the Articles of Association of the Company) or otherwise disposing off an asset of the Company having a value in excess of Rs. 1,00,00,000 (Rupees One Crore only), in a single transaction or a series of connected transactions, is required to be consented by way of a resolution of the shareholders of the Company at a general meeting.

Pristine Mega Logistics Park Private Limited ("Borrower"), a wholly owned subsidiary of the Company, is proposing to avail rupee term loan up to an amount of Rs. 20,00,00,000/- (Rupees Twenty Crore only), cash credit and bank guarantee up to an amount of Rs. 90,00,00,000/- (Rupees Ninety Crore only) (collectively, referred to as the "Facilities") from ICICI Bank Limited ("Bank"), by entering into requisite transaction documents with the Bank. Catalyst Trusteeship Limited is proposed to be appointed as the common security trustee ("Common Security Trustee") in relation to the Facilities.

The Facilities to be availed by the Borrower will be utilized for, *inter-alia*, repaying the existing credit facilities availed from IndusInd Bank Limited, meeting/reimbursing capital expenditure incurred/to be incurred by the Borrower and/or refinancing the existing term loan facility availed from Tata Cleantech Capital Limited.

One of the conditions of the Bank for granting the Facilities to the Borrower is that the Company shall provide a first ranking pari passu charge (for rupee term loan) and a second ranking pari passu charge (for cash credit and bank guarantee) by way of mortgage on the immovable properties of the Company located at village Chawa, village Bhorla and village Harbanspura (admeasuring approximately 11 acres), in favour of the Common Security Trustee.

The Board has at its meeting held on April 11, 2025, subject to the approval of the shareholders, granted its approval for providing the above-mentioned security in favour of the Common Security Trustee.

Accordingly, the Board recommends the resolution set out at item no. 1 for the approval of the shareholders as an ordinary resolution.

The relevant documents related to the proposed resolution at item no. 1 will be available for inspection by the members at the registered office of the Company during the business hours till the conclusion of the extra ordinary general meeting.

None of the directors, key managerial personnel of the Company, and/or their relatives is concerned or interested, financially or otherwise, in the resolution set out in item no. 1 except being associated with the Borrower as directors.
